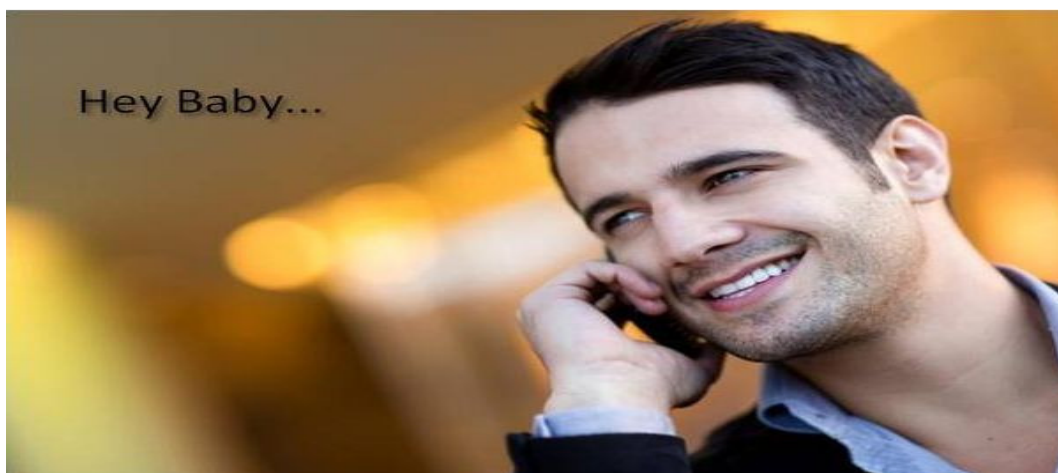

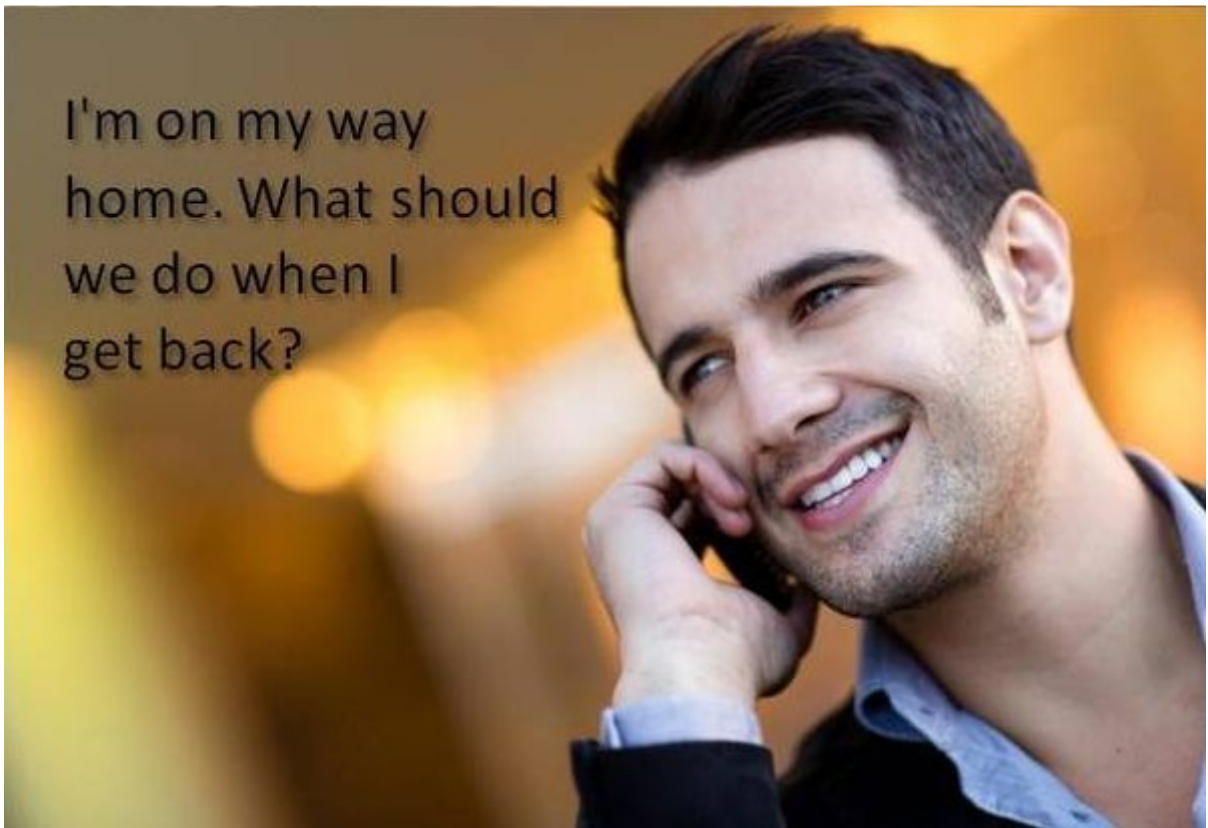
JT: If there is any man and woman in them they will enjoy some famous Irish whiskey.

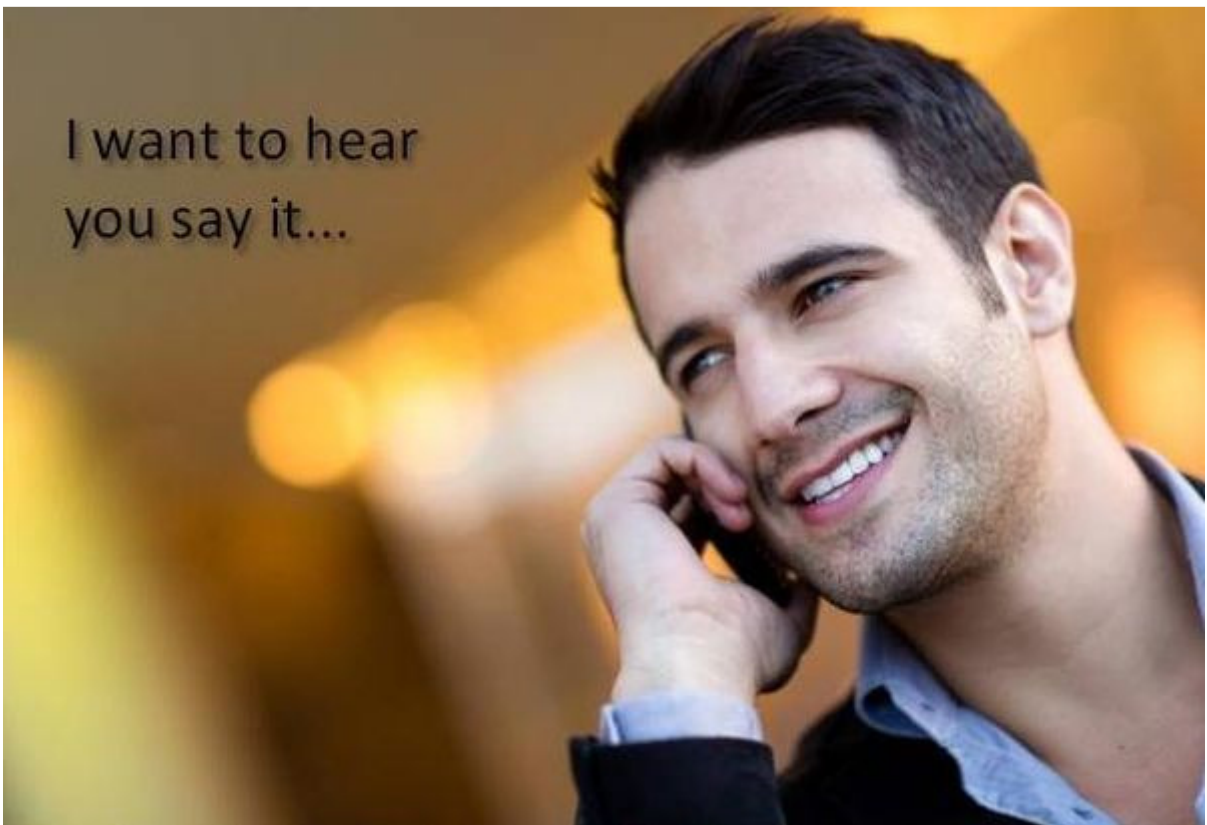

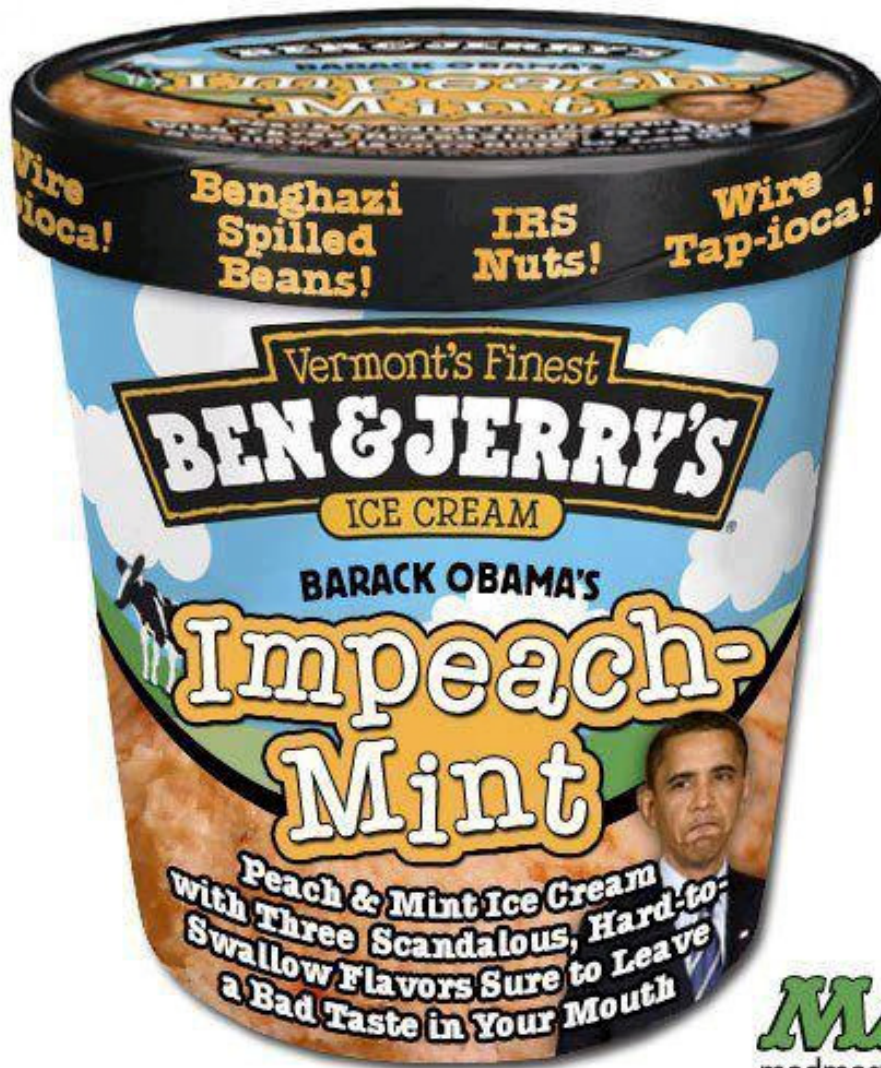
