[On January 6th, 2007](#), they were going to a friend's birthday party. The next day, when Channon did not show for work, her parents called the police. The two were carjacked by 5 young black people — four men and one woman. Channon was forced to call her parents at around 12:30 AM to tell them she would be late, so these demons could take their time with them.

These evil individuals gagged Chris with a sock, bound his ankles with his own belt and tied his hands behind his back. His face was covered with a bandana and his head was covered with a sweatshirt that was tied around his neck. He was almost beaten to death and violently raped with a foreign object. [Channon was forced to watch](#) as Chris was raped — then they cut his genitals off. He was then forced to walk barefoot on nearby train tracks, where he was shot in the neck and the back, paralyzing him, but not killing him. They dumped her upside down in a garbage can in the kitchen where she slowly suffocated to death. The judge in the case believes she may have lived up to 24 hours before dying there. When they found her on Tuesday, her eyes were open. I'm sure in her terror and pain, in the end she prayed to God to end it. I'm sure these kids thought of their parents and their families who they would never see again in this lifetime. George Detroit Thomas, age 24, faces a total of 46 charges. Thomas was indicated on 16 counts of Felony Murder growing out of rape, robbery, kidnapping and theft of Channon Christian and Christopher Newsom. Two Counts of premeditated murder of Christian and Newsom, 2 counts especially aggravated robbery from Christian and Newsom, 4 counts especially aggravated kidnapping of Christian and Newsom, 20 counts of aggravated rape of Christian and Newsom and 2 counts of theft from Christian and Newsom.

Vanessa Coleman, age 18, faces a total of 40 Tennessee State charges. Coleman was indicated on 12 Counts of Felony Murder growing out of rape, robbery, kidnapping and theft of Channon Christian and Christopher Newsom. One count premeditated murder of Christian only, 1 count of especially aggravated robbery of Newsom only, 4 counts especially aggravated kidnapping of Christian and Newsom, 20 counts of aggravated rape of Christian and Newsom and 2 counts of theft from Christian and Newsom.

Eric E Boyd, age 24, was arrested in connection with the carjacking, but faces only federal charges as an accessory after the fact. [Read more.](#)

It should be the death penalty with special circumstances all the way around here — for all of them. We should not pay to let them live — they should be executed with extreme prejudice. But, no... [Here is what they got:](#)

Vanessa Lynn Coleman was not convicted in the murder of Chris Newsom. She is serving a sentence of 35 years, but will be eligible for parole in mid-2017 after being convicted of “anal rape” and the “facilitation of murder” and “kidnapping.”

George Thomas was tried and retried and in June 2013 his attorneys have asked for “either a new sentence or a new sentencing hearing.” He is sentenced to [back-to-back life sentences](#) with no parole for the murders of Ms. Christian and Mr. Newsom and 25 years on rape counts. Thirty-eight charges. Thomas was found guilty of all 38 and he was granted a retrial, which you and I paid for and his attorney is wrangling for more from We the People. I believe he will be [eligible for parole at the age 75.](#)

Lamariacus Davidson received the death penalty. Apparently Holder hasn’t had a chance to vacate that sentence.

Letalvis Cobbins (Davidson’s step brother) – sentenced to life without parole.

Eric Boyd is serving an 18 year sentence. Boyd was convicted of being an accessory to a fatal carjacking, concealing the crime from law enforcement and hiding Lemariacus Davidson after the crime. [He is still considered a suspect in the murders.](#)

That is adding insult to injury and is a travesty. Tennessee, you should be ashamed. I agree with Glenn Beck, “Oprah, you disgust me.” As do all the other racebaiters including Sharpton, Jackson and especially Obama.

Of the four charged at the state level, three (Letalvis D. Cobbins, Lemaricus Davidson, and George Thomas) had multiple prior felony convictions. After a jury trial, Lemaricus Davidson was sentenced to death by lethal injection and Letalvis Cobbins and George Thomas were sentenced to life in prison, Cobbins without the possibility of parole and Thomas with the possibility. Vanessa Coleman has been convicted of facilitating the crimes and sentenced to 53 years in prison, and Eric Dewayne Boyd has been convicted of federal charges as accessory after the fact to carjacking and sentenced to 18 years in prison. The state convictions were set aside because of misconduct by the presiding judge, who has since been disbarred; retrials (pending appeals in all except the Coleman case, whose retrial is not being contested) had been tentatively slated for the summer and fall of 2012, but in May 2012 the Tennessee Supreme Court vacated the motion for new trials. All of the state convictions (except for the Coleman case) were permitted to stand and the defendants remain incarcerated pending appeals. To date, only Coleman has been retried, with a reduction in term from her original sentence by approximately one-third.

"The rule of [former President Mohammed] Morsi showed how in less than a year they [the Muslim Brotherhood] abused the people, reneged on their promises and overturned the rule of law by issuing constitutional diktats monopolizing the judiciary as well as the legislative arms of the state. This was enough to impeach any president in a democratic nation. Unfortunately, Egyptians couldn't refer to their Supreme Court as it was besieged by thugs for over 60 days back in November of 2012. So finally, Egyptians took to the streets and this century's second Egyptian 'peaceful unarmed' revolution took place in June 2013 to recall the president and reject the rule of the Brotherhood. The letter continues: "Now, I would like to address a few points in your address: Despite the perception, well-intentioned or ill-intentioned, history will tell of a Western media consistently portraying only one side—the Islamist's. We have to let you know some facts and some truth. Since July 3, 2013, the day deposed President Morsi was ousted by popular demand of millions of Egyptians, the Western media and prominent emissaries from the U.S. and Europe have consistently described the sit-ins that paralyzed a large part of Cairo as 'peaceful demonstrations.' They chose to ignore what was happening across Egypt from torching churches and killing randomly and destroying private and public properties. Mr. [Obama], peaceful demonstrators do not have the capacity to kill more than 50 police personnel in just a few hours. Peaceful demonstrators do not attack a police station with RPG [rocket propelled grenades] and kill the police chief and his deputies, strip them of their clothes and drag their naked bodies down the street. Peaceful demonstrators do not threaten Christians with genocide as many of the Muslim Brotherhood declared in hate speeches from the sit-in stage. Peaceful demonstrators do not raise the black flags of al-Qaida while marching with pictures of bin Laden and al Zawahri on their chests. While the Western media was focusing yesterday on the clearing of the sit-ins, more than 45 attacks were made on Christian installations across Egypt, resulting in the torching of 19 churches and cathedrals, some built in the 6th Century."

"The list goes on, but your intelligence reports will enlighten you, we are sure. The attached video here will also give you an idea. Mr. [Obama], it is important that you see reality, especially that the great American people have themselves suffered from the darkness of Islamists and unfortunately thousands of great Americans died from their terror. We also hurt to see mothers mourn their children and children mourn their parents. Have you seen, Mr. [Obama], the video clip of the Muslim Brotherhood supporter throwing 14-year-old children off the roof of a six-floor building? One mother died of sorrow when she saw the video clip of her son thrown off the building. She did not have time to mourn. Today Mr. [Obama], you chose to consider one side of the picture and to punish the Egyptians by canceling Operation Bright Star. Well Mr. [Obama], Operation Bright Star means nothing to most Egyptians, but it is the misunderstanding and misleading of the American people that we care most about. Egyptians have always stood by the American people when attacked by terrorists because we are freedom lovers and individual liberty champions like the American people. The only difference is that we have always been deprived of these great principles and rights.”

“Is it too much for Egyptians today to have the support of the American people during our own war on terror? How can the same group be named terrorists in the U.S.A. and peaceful demonstrators in Egypt? How can these be the ones the U.S.A. will never negotiate with while the U.S. government demands that Egyptians not only negotiate with them but also partner with them in the building of modern Egypt? Mr. [Obama], the interest of peace in the region is served best by truly peace-loving people and democratic values. Finally, Mr. [Obama], we hope that this letter will get your attention for, after all, we are now representing the majority. Our present government represents us, the secular, civil and liberal political forces. We hope that you will find it of value to probe more and investigate more and ask more. When you do, we are ready to come to you in a small delegation and discuss and explain more. Tobin writes, “There’s some soul searching going on in the Obama administration as it ponders how they got sidelined in Egypt as the situation there got out of control in a spiral of violence. ...[T]he administration went all out to persuade the military that had overthrown the Muslim Brotherhood to compromise and allow the Islamists to rejoin the government. Among other efforts to cajole them or to threaten aid cutoffs, Secretary of Defense Chuck Hagel made 17 often-lengthy phone calls to Egyptian General Abdul-Fattah el-Sisi trying to get him to make nice with the Brotherhood. They even sent two Republican senators—John McCain [R-AZ] and Lindsey Graham [R-SC]—to continue the pressure in person in Cairo. And they’re baffled as to why they were ignored as Sisi ordered police and troops to clear out the Brotherhood’s armed camps in Cairo this week. ...The easy answer to their questions is that unlike Sisi and the military, ...Obama and his foreign policy-team continue to fail to understand that the conflict in Egypt is a zero-sum game. The choice there is between the military and the Brotherhood and the

transformation of a key Arab country into an Islamist stronghold. This failure to comprehend the nature of the conflict has led inevitably to paralysis. ...As Sisi prepares to decide whether to enact a ban on the Brotherhood that might bring the confrontation in Egypt to a head, it's important to understand that Obama's failure in Egypt is not unrelated to his problems elsewhere. The common thread is a refusal to abandon its preconceptions and to look at facts rather than fiction inspired by ideology."

The Obama administration, observes Tobin, "pressured the military to let Mohamed Morsi take office and then continued to urge them to stand aside as he proceeded to demonstrate that the Brotherhood had little interest in democracy. Even as 14 million people took to the streets to demand that Morsi step down, [Obama] continued to preach restraint and then stood by in puzzlement when the military realized that this was probably their last chance to save their country. Even now, the administration seems stuck in the same mythical 'Arab Spring' mindset that is predicated on the idea that a totalitarian movement like the Brotherhood is compatible with liberal democracy. Since they don't understand what led to the events of the last week, how can we expect the Obama team to put forward a coherent position on what happened and what may unfold in the days to come? ...While critics from both the left and right assail Obama's indecision that... protects neither American interests nor values in Egypt, this is yet another symptom of an administration that remains besotted with the same preconceptions that it brought to Washington in 2009. While he laments his lack of good choices and the fact that America's ability to influence events is limited, it is [Obama's] refusal to face facts about the Brotherhood and some of his other blind spots that is most to blame for the fact that he has left American foreign policy hanging in the wind at a decisive moment in history."

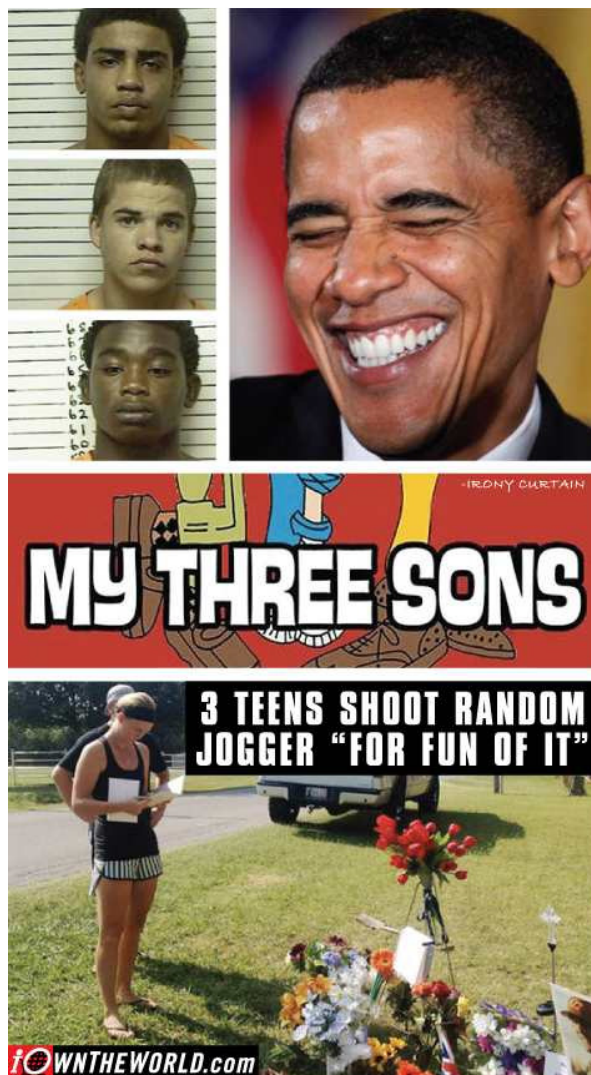

"First Amendment: An Oklahoma constitutional amendment barring the state's courts from weighing or using Sharia law was struck down in federal court. How can a law written to protect the Constitution be unconstitutional?

Only in the parallel universe of judicial activists in which U.S. District Judge Vicki Miles-LaGrange resides can a law barring a particular religion's influence over court decisions be considered under the First Amendment of the Constitution as an unconstitutional establishment of competing religions.

"While the public has an interest in the will of the voters being carried out, the court finds that the public has a more profound and long-term interest in upholding an individual's constitutional rights," Miles-LaGrange wrote in her decision.

That individual would be Muneer Awad, a Muslim and U.S. citizen who once was executive director of the Oklahoma chapter of the Council on American-Islamic Relations, and who filed a lawsuit on Nov. 4, 2010, seeking to block the Save Our State amendment that had been approved by 70% of Oklahoma voters two days earlier.

On Nov. 29, 2010, Miles-LaGrange issued a preliminary injunction, finding that Awad had legal standing and that the amendment likely violated both the Free Exercise Clause and the Establishment Clause.

On Thursday she issued a permanent injunction, writing in her order that "it is abundantly clear that the primary purpose of the amendment was to specifically target and outlaw Sharia

law and to act as a pre-emptive strike against Sharia law to protect Oklahoma from a perceived 'threat' of Sharia law being utilized in Oklahoma courts."

Of course it was, and it's Oklahoma's right to do so. The First Amendment says "Congress shall make no law" but says nothing about the states and their inhabitants. Indeed, when this country was formed the original 13 states had various forms of established religions. The First Amendment was written to prohibit federal imposition of religion, not to prohibit states rights in that arena.

The amendment read in part: "The courts shall not look to the legal precepts of other nations or cultures. Specifically, the courts shall not consider international law or Sharia law."

Miles-LaGrange, while complaining that the amendment targeted a specific religion, also said it would have made no difference if the amendment had wording saying that Oklahoma courts "shall not look to the legal precepts of other nations or cultures."

This reflects a growing judicial activism and subversion of American jurisprudence. In his book, "Coercing Virtue: The Worldwide View of Judges," the late Judge Robert Bork cites the example of Supreme Court Justice Stephen Breyer's references to the "useful decisions" by the Privy Council of Jamaica, the Supreme Court of India and the Supreme Court of Zimbabwe for a 1999 case involving allowable delays of executions."
